Victor OGNIVTSEV is Officer-in-Charge of Trade Analysis Branch, Division on International Trade, UNCTAD secretariat. In this capacity, he supervises research and analysis of global and regional trade-related policies and strategies; monitoring the evolution of international trade, in particular issues of concern to developing countries. With regard to non-tariff measures (NTMs), Victor coordinated organization and work of UNCTAD-initiated Group of Eminent Persons on Non-tariff Barriers (NTBs) and its Multi-Agency Support Team. Most recently, he coordinated UNCTAD's contribution to a successful launch of a joint Transparency in Trade Initiative (TNT), which is implemented jointly by UNCTAD, the World Bank, International Trade Centre and the African Development Bank, He also supervises trade policy research and analysis, including on several new topics such as integration of developing countries in global supply chains and raising their exports' value addition. Earlier (in 1989-2003), he coordinated UNCTAD's research, policy and economic analysis, and technical cooperation in support of developing countries and economies in transition acceding to the World Trade Organization (WTO) and contributed to UNCTAD's policy analysis and technical assistance to developing countries during and after the Uruguay Round of multilateral trade negotiations. Victor holds an advanced university degree from the Moscow State University of International Relations.

Christian Knebel is Associate Expert in the Trade Analysis Branch at UNCTAD. He specializes on research and technical cooperation regarding trade policy, particularly non-tariff measures and regional integration. Previously, he was a consultant at the Market Analysis and Research section at the International Trade Centre (ITC, Geneva). He authored reports about obstacles to trade faced by companies in Malawi, Peru, Sri Lanka, Paraguay and Uruguay, and assisted their governments on trade policy issues.
